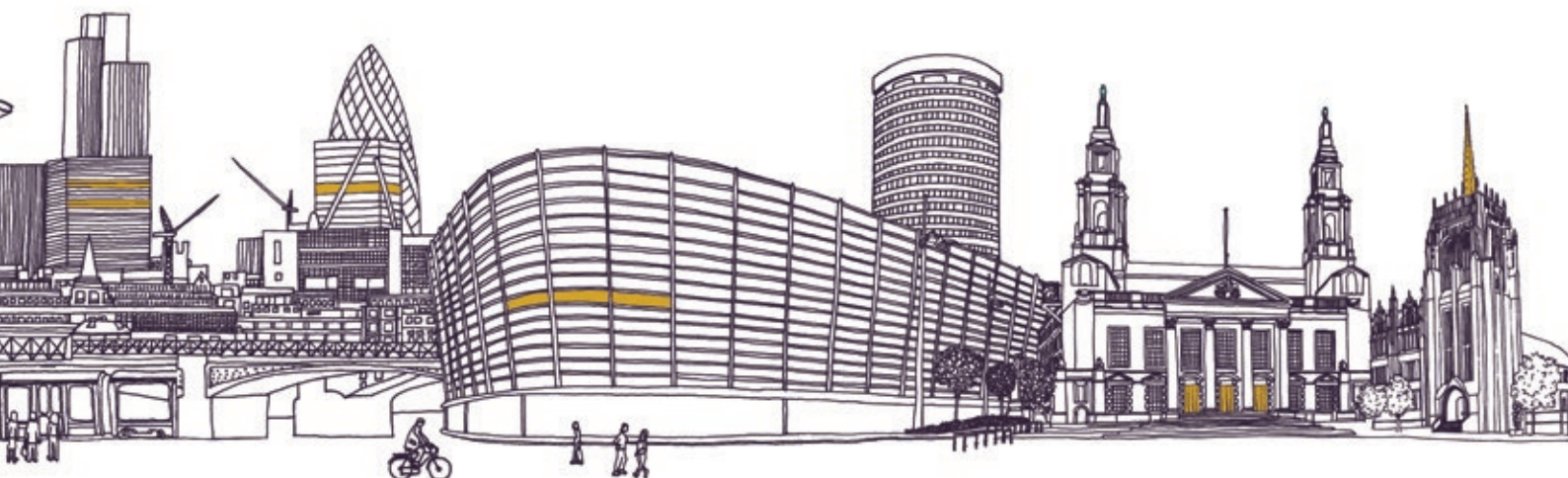

2015

2015 has been a positive year for the deals market and, as seen last year, confidence is continuing to grow, suggesting that the recovery is well underway. As the global and national recovery gains momentum, we have seen a resurgence in businesses looking to expand and seek further growth through investment opportunities and acquisitions.

Growth during 2015 was primarily driven by the services sector, which represented nearly three quarters of UK productivity. With low consumer price inflation, increased earnings and record levels of employment, the UK's economic future looks broadly positive. The industrial sector has been the most active for our Corporate teams, and our teams have also seen positive activity from clients based within the health, retail and consumer sectors.

In June 2015 Gateley (Holdings) Plc listed on the AIM market of the London Stock Exchange, becoming the first British law firm to do so, which positions us to take advantage of the changing legal landscape.

Our deal activity has been very encouraging and we have advised on deals involving some of the country's best known brands. In 2015 our Corporate and Banking & Finance teams helped clients deliver on more than 200 significant deals, with an aggregate deal value in excess of £1.4 billion.

This strong performance hasn't gone unnoticed, and our teams continued to feature highly in the Experian Corpfin M&A Advisor League Tables which ranks firms by deal volume. With the release of the 2015 Experian Corpfin Advisor League Tables in January 2016, the firm ended last year ranked in first place nationally, moving up from third place.

Regionally, our Corporate teams also performed well. Our Midlands Corporate team finished the year maintaining its first place position for the third year running, having advised on 62 deals, 17 more than its closest competitor. Our North West Corporate team also moved up the rankings in its regional league table, climbing from fifth to second, advising on 53 deals for the year. Our Yorkshire Corporate team continued to show evidence of its growing reputation, ranking seventh for a second year, despite being established only two years ago.

Our Corporate teams in the Midlands enjoyed success at two key regional business awards in 2015 winning 'Corporate Law Firm of the Year' at the 2015 Midlands Insider Dealmakers Awards in September. The team also advised on deals that won the 'SME Deal of the Year' award and 'Deal of the Year' for the £307 million acquisition of the NEC by LDC. Our East Midlands based Corporate team were also recognised for their expertise, having been named 'Legal Team of the Year' at the East Midlands Dealmakers Awards at the beginning of 2015.
